Final Report of the Arbitration Committee Meeting of ECO Chamber of Commerce and Industry (ECO CCI) Nov 5, 2012, Ankara -Turkey

1. The Third meeting of the Arbitration Committee of ECO Chamber of Commerce and Industry, hosted by Union of Chambers and Commodity Exchanges of Turkey (TOBB) was held on November 5, 2012 in Ankara- Turkey. The representatives of the Arbitration Committee from Chambers of Commerce and Industry of the Islamic Republic of Iran, Republic of Turkey, Islamic Republic of Pakistan, Republic of Kazakhstan, Republic of Tajikistan, Islamic Republic of Afghanistan as well as the representative from the ECO Secretariat participated in the meeting.(list at Annex I)

4. A Drafting Committee consisting of representatives and members of the Arbitration Committee was formed to prepare the Draft Report of the Meeting.

5. The Chairman of Arbitration Committee, Dr. Mohsen Mohebbi, delivered his speech in which he elaborated on the decisions of the previous session of the Arbitration Committee and the support by the RPC from the ECO CCI Arbitration Centre which was consulted with member chambers and its resulted in the decisions of the 22nd RPC Meeting regarding the accession of member states to 1958 New York Convention on Recognition and Enforcement of Arbitration Awards which the Tajikistan has recently joined and only Turkmenistan has not still acceded.

He made following proposals:

- To support the member chambers for holding workshops on arbitration in member states.
- To invite the member chambers to communicate with the ECO CCI regarding the development of the legal infrastructures for execution of arbitration awards.
- To invite also the member chambers to provide their comments on the documents of the proposed ECO CCI Arbitration Centre i.e. Arbitration Rules and the Internal Regulations of the ECO CCI Arbitration Centre.

6. The Secretary General, ECO CCI presented the Activity Report of the ECO CCI since the last meeting of the Arbitration Committee in November 19, 2011 in Karachi, I R Pakistan (Annex II)

Member chambers expressed support in general the establishment of the ECO CCI Arbitration Center and gave an account of its advantages.

After full span deliberations among the members of the ECO CCI Arbitration Committee following points were agreed:

- TOBB requested from the ECO CCI Secretariat to follow up the ICIEC's study on establishing an arbitration system among the OIC countries and inform the Member Chambers on the developments.
- The Meeting requested the ECO CCI Secretariat to collect the written proposals of ECO member states, in cooperation with the ECO Secretariat, regarding the nature of back up support to develop an arbitration system in the ECO region in line with the decision of the 22nd RPC Meeting.

- The Meeting requested the ECO Secretariat to approach the member states, which have not signed and/or ratified the New York Convention on the Recognition and Enforcement of Foreign Arbitral Awards, the Washington Convention on the Settlement of Investment Disputes (ICSID) and the Geneva Convention, to sign and/or ratify the abovementioned Conventions for the purpose of creating a scope to ease arbitration implementation in the member states.
- The Workshop/Training Course/Seminar on Arbitration among the ECO member states to be held in Tehran, I R Iran and Ankara/Istanbul- Turkey subject to the approval of the Executive Committee.
- The joint workshop on arbitration to be held in collaboration with the ECO Secretariat, ECO CCI and UNCITRAL.
- The legal advisors of member chambers from the private sector having enough knowledge of trade related issues accompany their respective chambers in the next meeting of the Arbitration Committee
- The ECO CCI still remains open to the opinions /comments raised by member chambers on the ECO CCI Rules of Arbitration and Internal Regulations of the ECO CCI Arbitration Center
- The Committee re-admitted the decisions taken in the 2nd Arbitration Committee Meeting that was held in Karachi, on 20 November 2011, under the Agenda Item No-6

Agenda Item No – 8:Briefing by the ECO Secretariat on RPC's approach towards supporting the establishment of the ECO CCI Arbitration Centre and holding the joint Workshop on Arbitration.

9. The ECO Secretariat delegate briefed with confirmation of the report of the 22nd meeting of RPC which was approved by COM concerning its support to establish the ECO CCI Arbitration Centre.

ECO Secretariat stated that the issue of holding a Workshop on Arbitration in coordination between ECO Secretariat, UNCITRAL and the ECO CCI and covering part of the costs of workshop is under consideration by ECO Secretariat.
