Final Report of 18th Executive Committee Meeting of ECO Chamber of Commerce and Industry (ECO CCI)

Tehran, I.R Iran - Oct 10,2013

1. The 18th Executive Committee meeting of ECO Chamber of Commerce and Industry (ECO CCI), hosted by Iran Chamber of Commerce, Industries, Mines and Agriculture (ICCIMA) was held on Oct 10, 2013 in Tehran-I.R Iran. The presidents/vice presidents of Chambers of Commerce and Industry of the Islamic Republic of Pakistan, Republic of Turkey, Islamic Republic of Iran, as well as the representative of Republic of Tajikistan (Commercial Attaché), Embassies of the Republic of Kyrgyzstan, Kazakhstan and Uzbekistan ,Deputy Secretary General, ECO Secretariat ,Vice President I.R Iran and President of I.R Iran Cultural Heritage ,Handicrafts and Tourism (ICHTO), ECO Trade and Development Bank (ECO TDB), I.R Iran Petroleum Ministry, I.R Iran Ministry of Foreign Affairs, Intelligent Persian Corporation (IPC), I.R Iran Ministry of Economic and Financial Affairs ,INC of ECO CCI as well as members of specialized committees of the ECO CCI participated in the meeting (list at Annex I).

Agenda Item-1: Inauguration of the Meeting

2. After the National Anthem of I.R Iran, verses from the Holy Koran were recited to the session;

Dr Mohammad Reza Karbasi, Secretary General of ECO CCI welcomed the participation dignitaries and delegates at the 18th Executive Committee Meeting of ECO Chamber of Commerce and Industry (ECO CCI) and gave a brief account of the sessions of the previous days comprising of ECO CCI Specialized Committees Meetings.

H.E Hayri Maraslioglu , Deputy Secretary General, ECO delivered his speech in which he described the achievements of the deliberations of the specialized committees and thanked the ECO CCI for holding these events.

He further touched upon the critical role of the private sector in the ECO region which will help realize the objectives of the ECO lead by the ECO CCI as he further called for operationalization of the ECO regional agreements in this regard.

H.E A.N.S Khamoushi, President INC of ECO CCI delivered his opening speech in which he enumerated the common religious, cultural and lingual common points of the member states of ECO as an edge in order to be utilized for regional integration calling for using the capacities of the ECO region in the face of the current global economic recession.

H.E Mr Camur Ali Kopuz , Vice President Union of Chambers and Commodity Exchanges of Turkey (TOBB) delivered his opening statements in which he called for promotion of intra ECO transactions and implementation of regional agreements of the ECO .

Vice President of the Union of Chambers and Commodity Exchanges of Turkey (TOBB) drew attention to the shift in global economy from the west to the east expressing that the 21st century will be the century of Asia-Pacific region. He called the member countries to remove the barriers of trade, to abolish visa, to standardizee customs procedures and to facilitate regional agreements on trade facilitate. In light of newly emerging economic bloc between the US and EU he underlined the importance of the enforcement of ECOTA as soon as possible.

To be competent with the global economy and to increase the competitiveness of ECO region he called the member countries to revitalize the ancient Silk Road based on multi model transportlines. Finally, Vice President of TOBB stressed the importance of vocational training and developing the human resources in the ECO region.

H.E Zubair Ahmad Malik, President, Federation of Pakistan Chambers of Commerce and Industry (FPCCI) addressed the session in which he mentioned the immense potentials of the ECO region with 6% of the world population.

He enumerated the ECO agreements such as ECO Trade Agreement (ECOTA), ECO Business Forum (EBF), Agreement on Promotion and Protection of Investment (APPI) as well as ECO CCI projects such as establishment of the ECO CCI Arbitration Center, Directory of 100 Top Companies which has been earlier published

H.E Dr. Mohammad Ali Najafi, Deputy President I.R Iran and President of I.R Iran Cultural Heritage, Handicrafts and Tourism (ICHTO) delivered his opening remarks where he touched upon tourism as a bridge between cultures and alleviation of economic gap among various countries.

In economic terms also he said that global tourists' spent over US\$ 1000 b in 2012 as also in case of ECO the tourism can greatly contribute to the intra regional and extra regional collaboration to introduce ECO as a global destination which is in need of proper tools , infrastructures and standards being situated amid the ancient silk road.

Visa relaxation and simplification (ECO Visa Sticker), nomination of tourism attaches within the member states' embassies ,holding the ECO Tourism Exhibition (either real or virtual through the internet), commemoration of the ECO Day, establishment of a tourism network and exchange of knowhow, training of the human resources, investments promotion are some of the ways to expands the intra ECO tourism collaborations which should come true via the close collaboration of the relevant authorities of member states were among the points made by H.E Dr Najafi.

H.E Dr. Mohammad Nahavandian, President of Iran Chamber of Commerce, Industries, Mines and Agriculture (ICCIMA) and ECO Chamber of Commerce and Industry (ECO CCI); delivered his welcome address (Annex II) in which he appreciated the ECO CCI for publication of the Directory of 100 ECO Companies in four sectors and made following proposals:

- In order to remove barriers to intra-ECO trade fast implementation of ECO Trade Agreement (ECOTA) to address the tariff and non tariff barriers is essential
- The Visa Simplification Agreement shall be given due attention
- ECO TDB is expected to cooperate with the ECO CCI to contribute to annual 1% growth in the intra-ECO trade volume
- Regular holding of the ECO Trade Exhibitions in member states as ECO CCI supports and cooperates in holding the next ECO Trade Exhibition in Tehran.
- ECO Business Forum (EBF) should be determined in terms of venue and date as 4th EBF and Buyers Sellers Meetings in Kabul is still pending

- Tourism, apart from being an important source of income, contributes to the development of service industries:
- Making due implementations in the transit area such as :
- Issuance of ECO Sticker Visa to transit drivers and valid in all member states,
- Harmonization of the working hours of customs offices of member states
- Activation of ITI/KTAI and other road and railroad corridors in the region
- Implementation of the Agreement on Promotion and Protection of Investment (APPI) by signatory-ratifying member states (signed by Afghanistan, Azerbaijan, Iran and Turkey and ratified by Iran)
- The member states shall join the New York Convention of 1958 on Arbitration.
- The legal infrastructures of member states shall be reinforced in order to implement the arbitration awards.
- Member chambers may collaborate in holding the UNCITRAL workshop on Arbitration
- In the field of Energy the ECO CCI actively participated at the 3rd Ministerial Meeting on Oil/Gas and Petroleum in Dec 2013 in Tehran

Hence it is expected that the Consortium of ECO Private sector oil/gas petroleum companies be formed and fortified by the private sector,

- Regarding the Visa Sticker Scheme it is expected that the relevant authorities of ECO member states give due attention in this regard.
- It was decided based on the Iranian the Governments-Private Sectors Dialogue Council a similar council be formed in the ECO region for which a declaration endorsed by all the chambers of commerce be communicated to the highest officials of member countries in order for such a council to be established in the region and the 1st session of this council be arranged in collaboration of the ministries of foreign affairs of member states.

The ECO CCI Secretariat was entrusted to make due communications with all the member chambers in this regard less than a month from the current session of the Executive Committee

• Governments be advised by the collective efforts of the member chambers on ways and means of doubling the intra ECO trade volume

The TOBB Vice President recalled the session that Turkey has adopted a law for Public-Private Sector dialogue and Turkey is ready to share its experiences with the member states. The FPCCI president also supported the above idea.
