  - Regarding the ECO CCI website <a href="www.ecocci.org">www.ecocci.org</a> and its tourism window, the member chambers were requested to provide the ECO CCI with detailed information on the status and capacities of tourism in their member countries to be uploaded onto this website.
  - Contact persons shall be appointed by all member chambers for following the information/knowledge sharing initiatives on a daily basis among the member countries.
  - Regarding the importance of the establishment of the branches of the Health Tourism Association in ECO Countries, the member chambers support the idea and would collaborate with the ECO CCI in this respect.
  - The meeting took note of the invitation made by the TOBB to all member chambers to the UNWTO Global Summit on the City Tourism that will be held under the auspices of the Ministry of Culture and Tourism of Turkey as well as TOBB on November 14 to 16.2012 in Istanbul. Turkey.
  - Listen, Connect and Collaborate approach shall be made in order to have the sustainable assessment of the tourism affairs in the region
