FINAL Report of the Fifth Women Entrepreneurs Council Meeting of ECO Chamber of Commerce and Industry (ECO CCI) Nov 6, 2012, Ankara-Turkey

1. The Fifth meeting of ECO Chamber of Commerce and Industry Women Entrepreneurs Council (ECO CCI WEC), was hosted by Union of Chambers and Commodity Exchanges of Turkey . 7. Mrs Safak Civici Head of TOBB WEC delivered her words on importance of women in the socio economic of today's life.

She mentioned illiteracy and lack of knowledge as the most important issue of women and called for awareness creating and training for women entrepreneurs.

She mentioned that TOBB- TEPAV (Economic Policy Research Foundation of Turkey) is willing to hold workshops for the businesswomen of ECO member countries and called on ECO CCI member chambers to support this initiative.

It was suggested that each ECO CCI member chamber to introduce their permanent representatives to the ECO CCI WEC (except Iran-Turkey and Pakistan).

<u>Agenda Item No-7: Presentations by member countries (Except Iran and Turkey) on</u> <u>five most prominent businesswomen in their countries</u>

8. Participating delegates (Except Iran and Turkey) made Presentations by member countries on five most prominent businesswomen in their countries;

Under this item Afghanistan delegate mentioned the religious and cultural common points among ECO member countries as one of the privileges for the ECO CCI WEC.

<u>Agenda Item No-8: Considerations on holding of short training courses for the businesswomen of Tajikistan in Iran</u>

9. Considerations on holding of short training courses for the businesswomen of Tajikistan in Iran was made under this agenda item and below decisions were made ;

• It was suggested that ECO CCI make the necessary arrangements for holding the 5th ECO CCI WEC in Dushanbe – Republic of Tajikistan.

In this regard the experts will visit to hold the Training Workshop for Tajik Businesswomen.

• The Tajikistan delegate mentioned a few points on the status of the businesswomen in the society of Tajikistan stating that holding a businesswomen event in Dushanbe would be subject to approval of the Tajik CCI President.

- The ECO Secretariat was requested to consider the possibility of extending its financial support and to propose a budget share for businesswomen events and activities in the region.
- The members of the committee expressed their intention for financial support for the travels of ECO businesswomen to different events from diverse sources.
- It was approved that the next meeting of the ECO CCI Women Entrepreneurs Council will be held in Kayseri, Turkey where the "Workshop on the future of Women Entrepreneurship and Capabilities in the ECO Region" will be held by TOBB-TEPAV along with that event.
- The meeting asked for documentation of the women experiences of member countries except Iran to be delivered by the respective member chambers in consultation with the ECO CCI
- The Workshop on Empowerment of the Women Entrepreneurs of ECO member countries was decided to be held in Tehran- I R Iran
